In this industrial tour our students could know how the distribution of PPL urea is from factory to field warehouse by both road and railways. They have seen how the raw material are transported from the port to the factory location and stored the factory premises. Consumption of urea is seasonal thereby rendering transportation storage and distribution is very much important.

Our students could know how fertilizers distribution is 80% by rail and 20% by road and (300km by road).For warehousing following services are uses such as Federations & cooperative godowns, Central warehousing corporations(CWC) and State warehousing corporations(SWC).

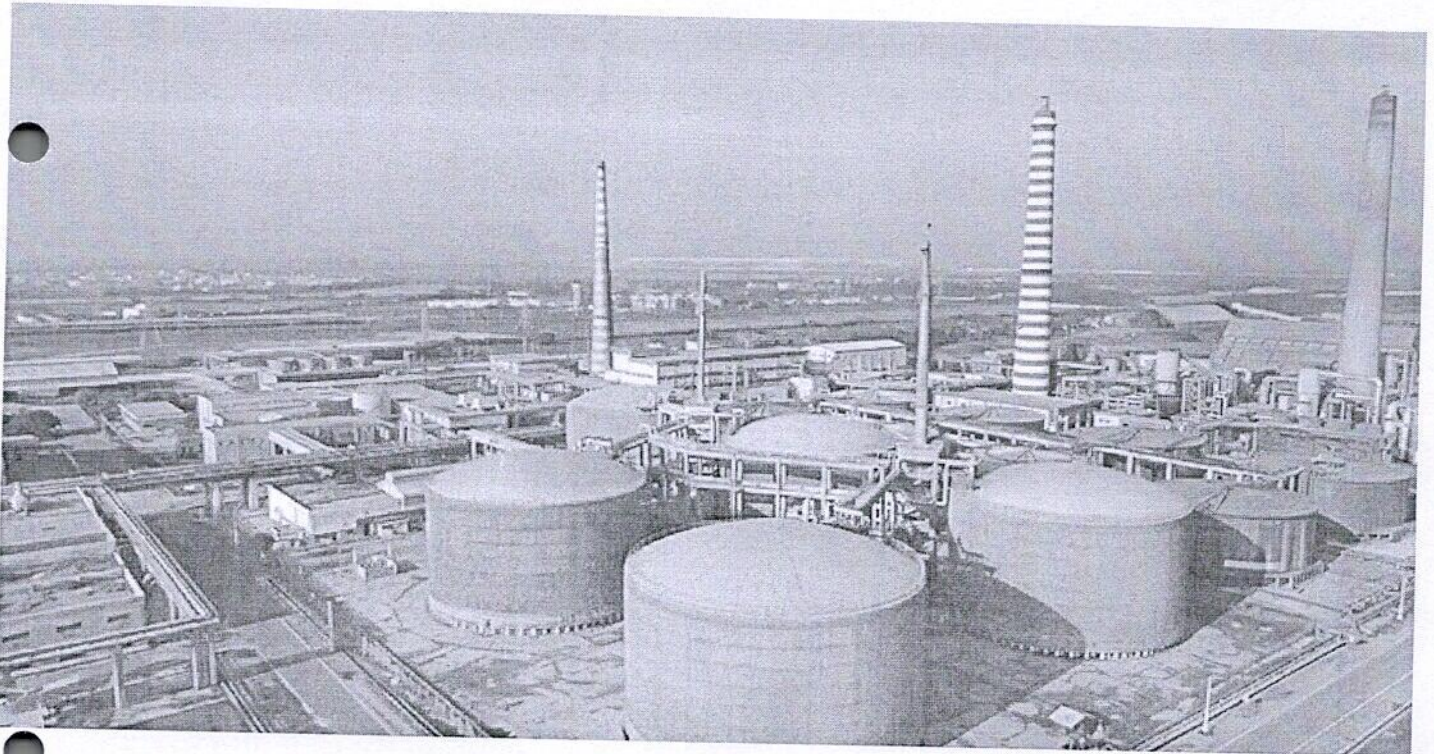

Paradeep Phosphates Limited (PPL) is one of India's largest private sector phosphatic players, producing a wide range of phosphatic grades including DAP, N-10, N-12, N-14, N-19, N-20 and N28. Our Goa Plant also produces Urea, and is a key supplier to the states of Maharashtra and Karnataka.
